

# <u>International Student Financial Information</u> <u>2018-2019 – Post-Baccalaureate Programs</u>

## **TUITION & ASSOCIATED FEES:**

The tuition and fees for 36 credits (12 courses) in Cape Breton University's post-baccalaureate programs is approximately \$22,316.00 CAD. Included in this amount are tuition, international differential fees, campus renewal fees, information technology fees, health insurance, and campus activity fee.

On-campus housing & meals fees are approximately \$6,700.00-\$12,000.00 CAD per academic year.

Students are required to be enrolled in the university's insurance policy for international students. No other carrier will be considered.

Students may pre-pay their tuition for their first year of study upon being accepted to Cape Breton University. All payments will be credited to their student account at the university and the funds will go toward their school fees once they register.

Please note that 100% of a student's deposit will be returned in the case his/her study visa is not granted (appropriate documentation required). For fully accepted students arriving to CBU with a valid study permit, should you choose to withdraw, 50% of your tuition deposit is classified as non-refundable and automatically withheld/forfeited to CBU. All international students who arrive in Canada choosing to leave CBU, must request a withdrawal and refund in person. Processing can take four to six weeks.

Students claiming Canadian landed immigrant status will be charged differential fees unless documented verification has been provided to the Finance Office at Cape Breton University.

# Congratulations on your acceptance to Cape Breton University!

As an International student there are a few additional steps you must take before you can register for your classes:

✓ **Student Online Access** – Register for a PIN that will allow you to use the Student Online Access system at https://sis.cbu.ca/students/StudentRequestPin.asp.

After obtaining your pin and logging in, please check your contact information under My Profile >>
My Current Profile. If the contact information is not your most recent contact information, please fill
out a *Change of Information* form. You can find this form at the Registrar's Office or <u>on our website</u>.

Transfer of Credit – If you have attended another post-secondary institution you may be eligible to apply for a transfer of credit assessment, if you have not already done so. You can find the form at the Registrar's Office or <u>on our website</u>. If you have applied for a transfer of credit you must wait for the results before meeting with your academic advisor.

Note: we will only review transfer credits for institutions listed on your application for admission.

Academic Advising – All new students are required to seek academic advising before registering. Information regarding advising can be found <u>www.cbu.ca/academic-advising</u>. You can also visit the First Year Advising Centre located in our Learning Commons and Student Life Centre.

International Advisors – Meet our International Advisors who will help introduce you to CBU campus life, and help you enroll in our mandatory International Student Health Plan. Registration – At the time of registration a \$300.00 (CAD) payment is due; students who are sponsored can wait for confirmation of funding to be received by our finance office before registering.
